The Fund: Unconstrained to a traditional benchmark, Fund managers scour the globe in search of investment opportunities both long and short. Implements a flexible approach to investing across the emerging and developed markets, providing global exposure that may help counterbalance performance swings in conventional holdings.

The Approach: Eaton Vance applies its global macroeconomic and political research process in directing Fund investments. This time-tested process informs long and short positions in sovereign asset classes, such as foreign currencies and sovereign credit markets. Managers consider relative risk and return in managing exposures.

The Features: A flexible mandate translates into investment opportunities in both improving and deteriorating markets. Potential for low volatility and managed with an eye toward risk-adjusted returns. Expected low beta may help the Fund complement traditional holdings. Ratings: The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and openended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. While the 10year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
